Some comments/questions may have to wait for a response until the next regular council meeting. The conducting Council Member will inform a citizen when he or she has used the allotted time. Grievances by City employees must be processed in accordance with adopted personnel rules.

**NO ACTION COMMENTS**

1. **SCHEDULING.** The City Recorder informed those at the meeting of upcoming events, meetings, activities, etc.
2. **CITIZEN’S COMMENTS. Jason Keffer, 524 Farmer Alumni Dr.** He has commented before about the importance of having a Citizen Review Board. He also added how important he feels it is to have plan in place if something goes wrong in the police department. He had a couple of questions from tonight’s work meeting about the Citizen Review Board.

Council Chair Bynum said there will be more discussion about a Citizen Review and police policies at future meetings.

**Mekeli Wesley, 3149 South State Street.** He purchased a business in South Salt Lake and has been trying to obtain a business license and has run into issues with the business licensing department. He wonders what steps he can take next and who to speak to about the issues he is having with that department.

Council Chair Bynum recommended that Mr. Wesley reach out to the Council via email regarding his concerns and in the meantime she will try to find out more information.

3. **MAYOR’S COMMENTS.** Mayor Wood stressed the importance of taking the Census and asked that the Council continue to spread the word about the Census. She also added that there is a lot of information regarding Mr. Wesley’s business and would like to talk to the Council about this further in the future.

- 5. CITY COUNCIL COMMENTS.** Council Member Pinkney had an email from a resident regarding the police department’s involvement with the Cottonwood Heights protests. A copy is attached and incorporated by this reference. She also added that she agrees with Mr. Keffer’s comments that were made about the Citizen Review Board and she believes by just reviewing police policy the Council isn’t making systemic changes. She said that she has had a lot of businesses reach out to her regarding their frustrations with the business licensing department and wondered if the Council could have further discussion regarding this.

Council Member deWolfe said some residents in the City voiced frustration with the Council’s decision on the temporary business ordinance that was passed by Council at the last meeting. He gave some clarification as to why the Council made that decision.

## **TO SAVE OUR PUBLIC POSTAL SERVICE**

### **Proclamation Against Privatization of the United States Postal Service**

The U.S. Postal Service, which was created as the Post Office Department in 1792, has its founding principles in the U.S. Constitution. To this day, it remains a national treasure belonging to the people of this country.

The Postal Service has remained a self-sustaining, independent establishment of the federal government that does not receive taxpayer funding and relies solely on revenue derived from the sale of postal services and products.

The Postal Service employs more than 500,000 people who are at the center of a \$1.4 trillion, 7.5 million employee mailing industry that has a positive economic impact on our community. The agency serves the needs of more than 157 million business and residential customers through its affordable universal network, providing service six and sometimes seven days a week.

This universal network connects the country's rural, suburban and urban communities at fair and reasonable rates, providing equal access no matter who we are and where we are located. This unmatched infrastructure coupled with a dedicated workforce is the reason that the Postal Service is consistently the highest-rated agency of the federal government. In fact, a Pew Research Center poll, released in February 2018, showed that the Postal Service has an 88% favorability rating.

The Postal Service remains the nation's second-largest employer of military veterans and is a source of decent and dignified union jobs and equal pay for workers from all backgrounds, including women and people of color. These employees are dedicated public servants who do more than process and deliver the nation's mail. They serve as the eyes and ears of the nation's communities and often respond first in situations involving health, safety and crime.

We know that if the USPS is privatized in whole or in part, the decision to provide services will be based on whether a company can make a profit rather than what's good for our communities. Inevitably, privatization will lead to increased rates and diminished services for customers, especially in rural communities and potentially in low-income urban areas.

Privatization of the Postal Service would jeopardize the booming e-commerce sector and cripple a major part of the nation's critical infrastructure during a time where methods of communication are constantly changing, while mail, including letters, cards, periodicals, medicines, catalogs and packages, continues to be invaluable to individuals and businesses.

Recently, the White House Office of Management and Budget and the Presidential Task Force unveiled plans for partial or total privatization of the Postal Service. Privatization will harm workers, communities, and businesses who are currently well-served by the Postal Service.

The \_\_\_\_\_ City (or County) Council goes on record opposing the privatization of the Postal Service so it remains an independent establishment of the federal government.
